3C) REPORT FROM RECORDING SECRETARY- Nothing to Report

4) PUBLIC COMMENT – Jennifer Johnson, Byron Johnson's wife, gave an overview of Byron Johnson's career and described his commitment to BCFPD and his family. Mrs. Johnson gave an overview of the incident and conversation with PSI, then asked several questions which included: What are the grounds for Byron's termination? What is the status of the termination papers? Was everyone that was present at the incident interviewed? Why wasn't Byron's one-up made aware of the situation? Why did the Chief not stand up for Byron Johnson? Why was

Byron not informed of her neck injury? Why was Byron not issued a PIP or a last chance agreement? Why is Byron not allowed to view the incident report? Mrs. Johnson provided a packet which included several testimonies to Byron's character and how he has impacted their lives. Mrs. Johnson stated that the BCFPD lost a good man on April 27. Mrs. Johnson stated that this is an injustice to him, his crew, to the entire community and to the entire society that such an egregious unfair termination could have happened without a fairly vetted investigation.

Lindsay Gertz, Byron Johnson's sister, read letters from co-workers of Byron Johnson, expressing their experiences and support. Stating Byron has a self-less devotion to the department, crew and community.

Lieutenant Caleb Meyers, wrote and read a letter in support of Byron Johnson stating that he has known Byron since January 30, 2018. He was his lieutenant on black shift, he has been his friend, mentor, and officer. Mr. Meyers stated he is calm level headed and exemplary at this job. In the past four years there has not been one incident were his character has been called into question, or any form of misconduct. Even in the face of these accusations Byron has been honest and shown complete integrity. Throughout his career he has promoted a safe environment. Lieutenant Meyers stated that this decision was wrong. The investigation was not thorough. I drove the person who brought these accusation to the station after the incident, I was not contacted, or informed of this situation.

Randy Thiel, retired lieutenant from Wauconda Fire Department, with 30 years of service, stating he met Byron over 20 years ago, and that he encourage Byron to enter the Fire Service. I have watched him mentor both newbies and experienced members using a clear and concise approach. Byron has raised a loving family, which is community oriented and involved with many charitable causes. Mr. Thiel stated that for an unsubstantiated accusation, that is quantifiably out of his normal character and in direct opposition of his documented appraisals leading to his termination is a travesty. Mr. Thiel urges the board to reconsider the actions of the District and PSI. The lifelong dream and careers of a dedicated and competent first responder should not be ended without a fair thorough investigation and explanation.

Charlie Buschick, retired from Wauconda Fire Department with 45 years of service. Mr. Buschick has worked with Byron many times and Byron has always been a gentlemen, a professional firefighter, excellent and proud leader. Mr. Buschick does not believe these accusations are true and everyone here needs a full explanation of what happened.

Joe Biasi, has known Byron since 2014, Byron as a firefighter and a lieutenant, in both roles he went above and beyond. He was always working on being the best version of himself. Byron helped everyone and was one of the guys you wanted on your shift. Mr. Biasi feels BCFPD made a wrong decision terminating Byron and feels he should be re-instated and he supports Byron Johnson.

Dan Johnson, Byron Johnson's brother, read letters supporting Byron Johnson, stating he is the most professional, motivated, dedicated, compassionate level headed and patient person he has known. Byron's family always came first and he had a knack for getting the best out of the individuals around him. Byron's leadership leads to a strong work place where individuals could come to work and feel safe, respected and learn something new each day.

Danielle Villaraza, stated that she worked for PSI at BCFPD from Dec 2016 through Jan 2019. She has worked with Byron on many occasions throughout her 2 years, Danielle read a letter stating that Byron conveys an infectious calm confidence, his knowledge and abilities cannot

easily be replaced. He was always welcoming and cultivated a good work atmosphere. The letter continued, for PSI to haphazardly terminate a leader of Byron's caliber is alarming. While terminating Byron is concerning, for those who understand the culture it is par for the course, the work atmosphere that PSI creates is hush is the word and don't ask questions, that is the policy. The Board of Trustees turns a blind eye to many of the problems that are consistently brought to them, describing the moral as toxic would be putting it kindly. These Firefighter/paramedics show up to work every day with an employer who underpays and under delivers and does the bare minimum for its employees. This is evident by the high turnover. Unfortunately these employees are afforded next to zero protection in situations like this.

Madison Moon, Byron Johnson's Daughter, stating that each of the statements read hear tonight reflect the man that Byron Johnson truly is, all the noble words that our highlighted thru all of them one theme arises, inspiring. He has inspired me, he is selfless, while family comes first the department was a close 2nd. He is dedicated knowledgeable and compassionate. My heart breaks for my dad as the career that he has found family within has been uprooted from him for unfounded over emphasized accusations of a new employee. A new employee who he was only trying to get to know better so she too could feel part of the community. To let a playful shoulder nudge be the end of a 20 year career and everything a man has worked for is baffling. My heart breaks for those who had the privilege to learn and work beside him, and have lost an exemplary teacher. How unsettling for each employee to watch the ease at which their Chiefs and PSI had at giving up such an exemplary employee.

Jim Goodwin, 914 Barrington Hills, former battalion chief and Byron's direct supervisor at that time, stating when he found out Byron was let go he was upset, appalled and embarrassed. You just opened every door in this building and everyone is going to run. Byron was the roots that held the place together, he was heart and soul. The Board needs to pay more attention and not let this happen ever again.

President Hanson, thanked everyone for those that spoke this evening, and it is appreciated and wished everyone the best.

The Meeting recessed at 7:10 PM

The Meeting resumed at 7:16, Trustees, Hill, Hanson, Long, Hower and Murray are present.

5) ATTORNEY REPORT – A written report was provided, stating that the notification documents from the McHenry County Assessor's office and McHenry County Clerk's office were completed, the Cook County tax bills are delayed till late 2022 or 1st quarter of 2023 and the Cook County tax levy documents are approved and will be sent back. Trustee Hower stated Wintrust Bank is have a seminar on the tax delay.
